previous actions in trying to stab me, that she was intending to stab my partner and possibly kill

ĥim.

CORBIN: Do you believe you had any alternatives to using the force at the time of the incident?

ANDERSON: No.

CORBIN: Can you (unintelligible) briefly retell us why you don't believe you had any alternatives?

ANDERSON: There was no time. We didn't have any shielding and we didn't have distance between us. There

was... literally feet between us.

CORBIN: So this would be, I guess, regarding Officer McNew. Can you describe any movements or

actions taken by Officer McNew before, during, or after the shooting?

ANDERSON: Um... Just verbalizing, 'Get back.' Uh, I believe he said. And, uh... um... And then... Where

he f-, he fired as well, um... And then, uh... after the incident, um... he checked in with me to see if I was OK and then, um, then we, I think, checking on the condition of the children and, um, the other juvenile that was in the... in the bedroom, uh... spoke to him briefly, just, I think, telling him to get back in the bedroom. And then, uh... when we were gettin' all the children out and the juvenile came out, he said something about shield... shield his eyes, um, something of

that nature as he was coming out.

CORBIN: What was he referring to?

ANDERSON: Shield the juvenile's eyes so he doesn't... see his mother... that's on the ground.

CORBIN: Um, did you approach subject Lyles after she was down?

ANDERSON: Um...
