NARRATIVE

On the evening of 10-04-10, I was working as a police officer for the City of Seattle. I am currently assigned to the North Precinct Anti-Crime Team and on the listed evening I was working with ACT Officers Hanely and Page. On the listed evening ACT officers were driving in an unmarked SPD vehicle wearing police markings looking for a felony DV warrant suspect, Michael L Edwards [REDACTED]. We had a DOL photo of Edwards and we suspected he was driving in a white Ford Tempo, WA# [REDACTED].

I observed the listed vehicle in the area of 14300blk of 32nd Ave NE and observed the driver to match the description of Edwards. We followed the listed vehicle and guided in patrol units to affect a traffic stop on the vehicle. ACT Officers saw patrol units activate there emergency lights and observed the listed vehicle pull into the parking lot at 3058 NE 137th. I exited my undercover vehicle and immediately recognized the drive to be Edwards. Edwards was given instructions to exit the vehicle and lay down on the ground. I then placed Edwards into handcuffs and searched his person. I removed several items from Edwards person and observed several small bags of suspected marijuana and several other empty baggies. All items removed from Edwards pocket were placed into a paper bag and I took control and transported it back to the SPD North precinct. SPD patrol units transported Edwards back to the SPD North precinct.

Once at the precinct ACT Officer Page went through all items removed from Edwards person. ACT Officer Page advised he took into evidence several small baggies which are used to package narcotics, 2 cellular phones, US Currency \$155.66, 8grams of suspected marijuana, small marijuana pipe with burnt residue inside and 10 tablets inside a paper napkin, which were later identified as Endoset, Schdelue II narcotic. I was able to identify the 10 tablets by using website Drugs.com. ACT Officer Page then advised he field tested the suspected marijuana which had positive results. ACT Officer Hanley advised he severed Edwards with a SPD seizure form for his US Currency, which Edwards understood and signed.

Once all necessary paperwork was completed for Edwards he was transported and booked into KCJ for Felony Warrant- DV Harassment and VUCSA PWI.

Arrested screened by ACT Sgt Chartrand.
